

MEMORANDUM OF COOPERATION

Between the Global Millennium Development Foundation (GMDF) and
the Intergovernmental Organization for Public Private Partnerships (P3 IGO).

PREAMBLE

This Memorandum of Cooperation (MOC) is entered into between the Global Millennium Development Foundation (GMDF) and the Intergovernmental Organization for Public Private Partnerships (P3 IGO) for the purpose of fostering collaboration in operational, programmatic, and development initiatives. This MOC establishes a framework for coordination between the parties in support of shared development objectives and aligned institutional priorities.

WHEREAS

- GMDF is a non-profit organization in Special Consultative Status with the Economic and Social Council of the United Nations.
- P3 IGO is a treaty-based organization dedicated to advancing development cooperation through Public Private Partnership frameworks and related programmatic initiatives.

ARTICLE 1: PURPOSE AND OBJECTIVES

The purpose of this MOC is to establish a cooperative framework for coordination between the parties in relation to programmatic initiatives, including knowledge exchange, institutional collaboration, and support for development-focused activities.

The objectives of this cooperation include:

- Facilitating coordination on initiatives aligned with the respective missions of both parties.
- Supporting information sharing and institutional engagement.
- Enhancing collaboration on development-oriented programs and activities.
- Strengthening operational alignment where mutually agreed.

ARTICLE 2: NATURE OF COOPERATION

This MOC establishes a non-exclusive cooperative relationship between the parties. Nothing in this MOC shall be interpreted as creating a legal partnership, joint venture, fiduciary relationship, or agency relationship between the parties. Each party retains full independence in its governance, operations, and decision-making.

ARTICLE 3: PROGRAM DESIGNATION AND STRUCTURAL STATUS

The Public Private Partnership Fund (P3 Fund) is a programmatic designation managed by the Intergovernmental Organization for Public Private Partnerships (P3 IGO), in coordination with the Global Millennium Development Foundation (GMDF). P3 Fund does not constitute a separate legal entity and does not possess independent legal personality.

ARTICLE 4: AREAS OF COOPERATION

Cooperation under this MOC may include, as mutually agreed:

- Programmatic collaboration on development initiatives
- Institutional engagement and stakeholder convening
- Collaboration for dialogue and capacity-building activities

ARTICLE 5: FINANCIAL ARRANGEMENTS

This MOC does not establish any pooled funding structure or shared bank account arrangement between the parties. Any financial contributions or tax-exempt related transactions, where applicable, shall be governed by separate written agreements between the relevant parties and shall not be implied by this MOC.

ARTICLE 6: IMPLEMENTATION

Implementation of any collaborative activities under this MOC shall be subject to mutually agreed written arrangements. Each party shall be responsible for its own costs unless otherwise agreed in writing.

ARTICLE 7: CONFIDENTIALITY

Both parties agree to maintain confidentiality of non-public information exchanged under this MOC, except where disclosure is required by law or agreed in writing.

ARTICLE 8: LIABILITY

Each party is responsible for its own acts and omissions. Nothing in this MOC creates liability for one party arising from the independent actions of the other.

ARTICLE 9: COMPLIANCE WITH LAWS

Each party shall comply with all applicable laws and regulations in the performance of its activities under this MOC.

ARTICLE 10: TERM AND TERMINATION

This MOC shall take effect upon signature and remain in force unless terminated earlier by either party upon thirty (30) days written notice. Termination shall not affect rights or obligations accrued prior to termination.

ARTICLE 11: DISPUTE RESOLUTION

Any dispute arising under this MOC shall be resolved through consultation between the parties. If unresolved, the parties may mutually agree to mediation.

ARTICLE 12: AMENDMENTS

Any amendment to this MOC must be made in writing and signed by both parties.

ARTICLE 13: EFFECTIVE DATE

This MOC becomes effective upon the date of last signature.
